## 2. Trial Registration Form – Deadline: (November 30, 2011)

Be sure to indicate on the form number of paddlers you are registering. Trial Registration fee's are non refundable and will be used towards final Paddlers Registration at the 2010 World Sprints. Failure to meet deadline may result in a crew not being able to participate in the Hawaii Trials or a Late Trial Registration Fee.

However, if there is one (1) change in an event, then you must complete and submit another Crew Roster form. Please print or type clearly.
